**Controls:**  
 All operators/Users of Quads shall wear suitable head protection (Helmet).  
 All vehicles must carry a basic First Aid kit.  
 If setting up on own operator must inform someone of where you are & how long you will be and carry a mobile phone at all times.  
 All vehicles must be taxed and MOT'd etc if to be used on the highway.  
 Operate Quads at a safe speed appropriate to the ground conditions on site & below the blanket speed limit for competitions at all times. Give priority to other vehicles descending hills, reversing or competing on a Special Stage. All marshals to wear Challenge South West high visibility vests and use lights if marshalling at night.
